D. HIGH SCHOOL COURSE ENROLLMENTS

Dr. Hodgdon will review current class enrollments in the High School and request School Committee approval to continue with six sections that are under the 14 student minimum. Laurie made the decision this summer, based on anticipated enrollments, to not run five sections of art classes. We left a one-year opening in art vacant, that opening as a result of a teacher being on leave for the year.

We can expect a report from the Student Advisory Board. The SAB representative to the School Committee will meet with Student Council and class officers following each School Committee meeting to share information from the meeting and will also meet from time to time to gather information for reporting to the School Committee.

G. SUPERINTENDENT REPORT

<u>Middle School Open House</u> — I know that Dr. Flaherty has reported on Middle School Open House in her report. I want to add the personal remark that I could not have been more impressed with the teacher presentations and the interactions that I saw visiting 15 or so classrooms. Our M.S. staff works very hard to ensure that Open House is a productive learning experience for parents and that home-school communication is at the center of all presentations and discussions.

Coordinated Program Review October 24-28 — The Massachusetts Department of Elementary and Secondary Education conducts a Coordinated Program Review of each district on a 6-year cycle. Patty Bullard and her staff have been preparing for this visit for almost a year now, completing many of the required pre-visit tasks and preparing the required documentation. The on-site visit will take place during the week of October 24-28. DESE staff will review records and interview staff, students, and parents. Some weeks after

the review, the DESE will share a draft report with the District outlining its findings and the corrective actions that will be required. Ms. Bullard will be sharing this information with the School Committee at a future meeting this year.

Senior Parents' Post Secondary Planning Night — This annual event was held on Thursday evening by the High School Counseling Department. It was a well-attended session with many of the parents present indicating that they were "first-time" college parents. I have included the parent hand-out with this email message to provide you with a flavor of the information that was presented.

9-11 Memorial at Masco — If you did not get a chance to see it, our students, again this year, placed a large number of miniature United States flags on the lawn in front of the school to bring remembrance to the tragedy that took place in 2001. It was, as always, a moving sight. I saw and heard many classroom activities in the days leading up to 9-11, activities important to keeping this memory alive for future generations.



Realignment of Essential School Health Services Grant Participants — Masconomet has been part of the Essential School Health Services grant for a number of years in a cohort group coordinated by the Rockport Public Schools. Newburyport will now be our lead district. Karen Trevenen and I met last week with Newburyport School Nurse Leader Kathy Riccio. We look forward to this new relationship and sharing resources and information through this new regional grant management center.

<u>Life is Good: The Book</u> — The first community read organizing meeting of the year will be held on Tuesday September 20th. We are looking forward to sharing what each of the towns and school districts is doing to promote this community read and working together to make it successful. I should have some details to report on Wednesday.

<u>Umbrella Organizations Meeting 9/21/16</u> — The first Umbrella Organizations meeting of the year will take place on Wednesday morning, September 21st. I am attaching the agenda and a member roster for your information. I will have details to report on Wednesday.

<u>Draft Vision and Values Statements Update</u> — The Vision and Values Statements presented to the School Committee on August 20th have since been circulated to all staff for comment.
